



LEGAL ALERT

Changes to the Law on Classifying Business Activities

Summary

1. These changes in the law are relevant to all businesses in Poland and are in force as of January 2008.
2. Compliance with the new law should be by 31 December 2009.

Detail of the changes

1. The new classification of business activities promotes all businesses in Poland to change (where required) their stated business activity (objects) in their articles of association, and register such in the court by 31 December 2009.
2. We recommend that companies comply with the new law and change their statutes (articles of association) and their entry in the court register (KRS register). Notification of the new PKD codes will have to be made to the State Statistical Offices and the Regon certificate updated.
3. There will be notary and court fees associated with these changes.
